Further to our letter dated 17th March 2026, we are writing to reconfirm the forthcoming Sika UK price adjustments and to provide further clarity on the percentage impact across our product

portfolio ahead of implementation.

Despite continued mitigation actions, sustained inflation across raw materials necessitate a partial price correction to maintain product availability, quality and service performance. In line with our commitment to fair, proportionate and transparent pricing, additional increases are being applied only where underlying costs exceed the broader surcharge.

Surcharge

The 4% surcharge on all orders implemented on 13th April will remain until we see the volatility reduced and the market normalised.

Please note, for any orders delivered from 13th April onwards we must receive written confirmation accepting the 4% surcharge for deliveries to be released. This can either be via email confirmation or as a separate line on the purchase order.


These price increases will take effect on **Friday 1st May 2026**. We will continue to monitor the ongoing situation and communicate any changes with 10 days' notice.

Our thoughts continue to be with those affected by the ongoing events in the Middle East.


